For what purpose and on what basis we process personal data

Bed & Breakfast 'Four Seasons' processes your personal data for the following purposes:

- To be able to call or e-mail you if this is necessary to be able to perform our services
- To inform you about changes to our services and products
- To deliver goods and services to you
- Bed & Breakfast 'Four Seasons' also processes personal data if we are legally obliged to do so, such as information that we need for our tax return.

Automated decision making

Bed & Breakfast 'Four Seasons' does not make decisions based on automated processing on matters that can have (significant) consequences for people. These are decisions taken by computer programs or systems, without involving a person (for example, an employee of Bed & Breakfast 'Four Seasons').

Bed & Breakfast 'Four Seasons' uses the following computer programs or systems:

- (desktop) Microsoft Office, Anti virus program, a firewall, VPN, social media for customer contact;
- (telephone / tablet) Android provided with a pin code or similar security for mobile traffic, email, social media for customer contact and payment transactions

How long do we keep personal data

Bed & Breakfast 'Four Seasons' does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected.

Sharing of personal data with third parties

Bed & Breakfast 'Four Seasons' does not sell your information to third parties and only provides it to third parties if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

Where we use a storage or processing by third parties, a so-called processing agreement is concluded, so that you know that your data will be processed in accordance with the regulations of the GDPR.

Cookies, or similar techniques, that we use

Bed & Breakfast 'Four Seasons' does not use cookies or similar techniques.

View, modify or delete data

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Bed & Breakfast 'Four Seasons' and you have the right to data portability. This means that you can submit a request to us to send the personal data that we have about you in a computer file to you or another organization mentioned by you. You can send a request for access, correction, deletion, data transfer of your personal data or request for cancellation of your consent or objection to the processing of your personal data to info@langevliet.nl. To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks.

Bed & Breakfast 'Four Seasons' would also like to point out that you have the opportunity to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.
